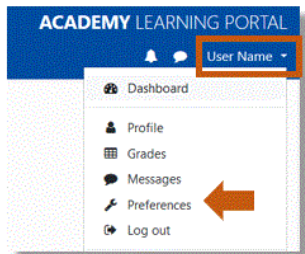

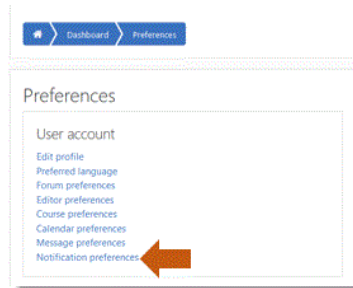


Manage your notifications on the Learning Portal

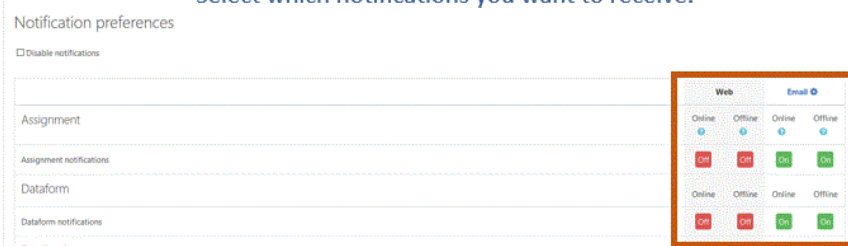
Open the drop down menu in the upper right-hand corner and select 'Preferences'
