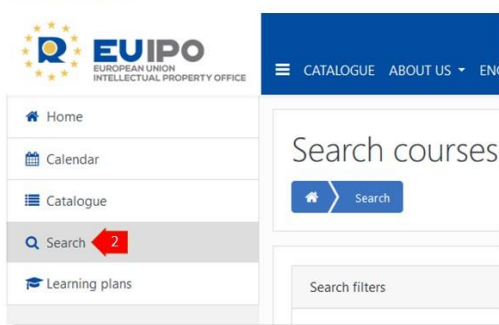


Accessing the advanced search function on the Academy Learning Portal

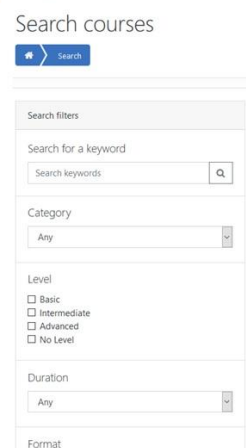
- 1 Open the sidebar menu by clicking on
