



Title of the event: CHARM-EU Virtual Challenge

Date of the event: 16 October 2020 at 11:00 CET

Aim of the event: The CHARM-EU Virtual Challenge is a contest designed by the CHARM-EU representative students under the framework of the #ErasmusDays 2020. The purpose of this contest is to generate interactions with all participants and exchange knowledge on the CHARM-EU Initiative and the Erasmus Plus Programme. The winner of the challenge will receive a complete CHARM-EU branding kit.

Terms and Conditions: CHARM-EU Virtual Challenge

- 1. This contest ("Contest") is organised by CHARM-EU initiative ("organiser") in collaboration with the CHARM-EU students' representatives.
- 2. The official language of the contest is English.
- 3. Participation in the Contest is subject to the present Terms and Conditions. - 6. Students from the Erasmus Plus programme countries¹ are eligible to participate and win.
- 7. The prize will only be delivered inside the territory of the European countries participating in the Erasmus Programme.
- 8. To enter the competition, please register to the event, providing us with your full name, address, email and phone number. All the submitted data needs to be accurate in order to be eligible to win.
- 9. During the event, you must have the Kahoot app in your mobile or access through the website: https://kahoot.it/ and insert your name and the pin provided during the live session.
- 10. All eligible participants should participate in the live event which will be held on 16 October 2020 at 11.00CET. Only students that participated in the live challenge are eligible to win.
- 11. No entries will be accepted after 11.00 CET. Promoter accepts no liability for any connection lost, delayed or damaged in transmission.
- 12. Registrations to this event can be made from 09 October 2020, 12:00 Central European Time (CET) up until 16 October 2020, 08:00 CET. Registrations received after this time might not be considered.
- 13. The student that answers more questions correctly in a shortest period of time will be the winner.
- 14. The winning participant will be awarded a CHARM-EU branded kit. In the event of the prize becoming unavailable, for whatever reason, the organiser reserves the right to provide an alternative prize of equivalent value.
- 15. There are no cash or credit alternatives available.
