

CALL FOR APPLICATION

Supplementary social financial support for students applying for Erasmus+ scholarship for studies and traineeship abroad

2020/2021 academic year

Eötvös Loránd University and the Tempus Public Foundation are announcing an application for **social-based supplementary financial support** for students studying in higher education who wish to win a study or traineeship mobility scholarship to an Erasmus+ programme country in the 2020/2021 academic year.

The aim of the social support is to provide more equal opportunities for outgoing students in the field of higher education mobility in the Erasmus+ programme.

The following criteria are taken into consideration during the submission of the support claims:

I. **Primary criteria** (the list is not in order of importance):

- during the application to the higher education institution, you received additional points as a disadvantaged student, or for equal opportunities
- you (have) received the Bursa Hungarica Academic Scholarship
- you (have) received a regular or emergency social assistance grant
- you were/are the beneficiary student of the Mentor Programme of the National Union of Students in Hungary (HÖÖK)
- you were/are the beneficiary student of the Hungarian „Út a felsőoktatásba” – „Út a diplomához” programme
- you were/are the member of a Roma college
- at the beginning of your higher education, you received a basic grant on a social basis
- a sudden change occurred in your social situation

The latter criterion can be justified by an unexpected economic and social change in the life of the applicant, which is specifically related to the period and events of the epidemiological emergency. Please justify and support the change, and present the eligibility on the part of the applicants. Such cases include:

- unexpected incapacity for work;
- unexpected death;
- other changes for which it was not yet possible to enforce the available social benefits.

II. **Secondary criterion:**

- The student is the permanent resident of one of the beneficiary settlements defined by Government Decree 105/2015. (IV.23)

The list of settlements is available on the claim form.

Who can apply?

Students who are applying for an Erasmus+ scholarship for studies and traineeship mobility abroad in the 2020/2021 academic year.

The amount of support

In addition to the Erasmus+ basic scholarship grant, in case of a **study abroad mobility, 200 EUR/month**; in case of a **traineeship mobility, 100 EUR/month**.

How to apply?

1. Submit a completed claim form

You may only submit your claim form on the official form completed with a computer. Please send:

- **1 printed, original version**, signed with a blue pen, to the coordinator of the sending institution, and
- **1 electronically completed (not scanned) version** to erasmus.out@dep.elte.hu

Eligibility according to the primary criteria must be proved on the application form. With the exception of documentation relating to a sudden change in the applicant's social situation, no separate certificate is required.

In case of *a sudden change in the applicant's social situation* (see. "primary criteria"), the following documents are accepted:

- proof of incapacity for work
- job search certificate
- death certificate
- in case of a long-term sick-pay: medical certificate
- other statements from the applicant

The "Certificate" section of the claim form must be completed, signed, and stamped by the official representative of the authorized organization.

In view of the epidemiological situation, it is acceptable if the applicant submits the form and the supporting document only in electronic form. Once the epidemic has ended, the original, signed form must also be submitted.

If you are (were) entitled to more than one of the listed options, please indicate this on the form, but it is sufficient to request a certificate for only one of them.

2. **In case the student is a permanent resident of one of the beneficiary settlements defined by the secondary criterion, a copy of the address card proving the permanent address must be submitted as an attachment to the claim form.**

Deadline of submission

The deadline for submitting the claim form for mobilities in the 2020/2021 academic year (both autumn and spring semesters) is:

June 19, 2020

*(During the second call of applications, the deadline for the Erasmus+ social supplementary application is **October 26, 2020**, but this is only applicable to students who are applying for mobilities in the spring semester of the 2020/2021 academic year.)*

Evaluation of applications, decision-making

The formal evaluation of the application is carried out by the sending higher education institution in consultation with the Tempus Public Foundation, and the Board of Trustees of the Tempus Public Foundation decides on the result of the application. In the event of an over-application of the available budget, the primary considerations will take precedence, and the contracting authority reserves the right to reject the application.
