

**INFORMATION ON THE PROVISION OF PLACING IN AN OFFICIAL HOME QUARANTINE OR DESIGNATED QUARANTINE FACILITY AS A TEMPORARY MEASURE**

**You have been placed in an official home quarantine / designated quarantine facility\* (hereinafter: quarantine) as a temporary measure by ..... (border crossing authority) from ..... (day) ..... (month), 2020, and you have been informed of this measure orally.**

The authority granting the temporary measure shall immediately notify the competent epidemiological authority of the temporary measure taken. Pending the decision of the competent epidemiological authority, the person quarantined during the quarantine period

1. may not leave the place of quarantine, may come into contact with others only in compliance with the rules ensuring the prevention of infection, may not receive guests;
2. is obliged to consult the treating doctor/doctor on duty in advance without leaving the place of quarantine in case of need for medical care;
3. must immediately notify the general practitioner or doctor on duty in the event of respiratory symptoms (especially fever, cough, shortness of breath), and follow the instructions given.

**Violating the rules of the decreed epidemiological isolation, monitoring, quarantine, and control, or the protection measure during the epidemic is an offense.**

If you are of legal age and legally competent, the police may also check compliance with the quarantine regulations by using an electronic software (application) that monitors your movement, and transmits your facial image and health data if you declare that you have the conditions to install the software, you have the appropriate equipment, and you voluntarily agree to install and use the software.

If you wish to make a statement with the aforementioned content, you can do so by accepting the statement that appears during the registration process during the software download.

**The warning sign provided must be clearly visible on the entrance door of the place of quarantine.**

\* It must be underlined whether the person will be placed in an official home quarantine or a designated quarantine facility in accordance with paragraphs 3 and 7 of the Hungarian Government Decree 408/2020 (30 August) on travel restrictions during the period of state of epidemiological preparedness.

## General Information on Hungarian Government Decree 408/2020 (30 August) on Air Border Crossing

The Government Decree is subject to change, so always pay attention to the updated Decree currently in force! (you may find the Decree in English here: [https://njt.hu/translated/doc/J2020R0408K\\_20200902\\_FIN.pdf](https://njt.hu/translated/doc/J2020R0408K_20200902_FIN.pdf))

- The following cases shall not fall within the scope of this Decree, i.e. entry is granted without restriction:
    - for entries with a **diplomatic, foreign official, service, or maritime passport** (*border crossing for official reasons*: crossing the border with a private passport or other travel document to conduct an official visit)
    - persons who, upon entering the territory of Hungary, certify in a credible way that they have gone through COVID-19 disease within 6 months before the day of crossing the border
  - **The entry of Hungarian citizens (the following shall receive the same treatment as Hungarian citizens: persons entitled to permanent residence in Hungary and their family members** (certified by a document), furthermore holding a valid permit to reside for more than 90 days within the territory of Hungary issued by the immigration authority under any legal title, who present the document to that effect upon entering the country):
    - **health screening in case of entry**
      - if the health screening raises the suspicion of COVID-19 → quarantine in a designated facility, or official home quarantine
      - if the health screening raises no suspicion of COVID-19 → provided that they have a domicile or place of residence in Hungary, official home quarantine on that address, or in case they do not, quarantine in a designated facility
  - **The entry of non-Hungarian citizens:**
    - **Entry shall be denied, except those persons who are granted permission to entry upon application by the District 18 Police Department of the Budapest Police Headquarters.** In all cases, the application must be submitted electronically in Hungarian or English (submit your application here: <https://ugyintezes.police.hu/en/uj-ugy-inditasa/> or via the Hungarian Client Gate) (more information in the Decree)
    - The person holding the entry permit shall present the **original document** to certify the grounds for application upon request by the police officer when entering the territory of Hungary. **Entry shall be denied** if the permit holder fails to present the original document, or any doubt arises regarding its authenticity upon entry
      - the permit holder is subjected to a **health screening**: if the health screening has raised the suspicion of COVID-19, entry shall be denied. If the health screening raises no suspicion of COVID-19, the person shall be placed in a designated quarantine facility or official home quarantine for 14 days
  - Provisions on travel between **affiliated undertakings**:
    - A person may enter without any restrictions the territory of Hungary from the territory of other states determined by the minister responsible for public safety, provided that they are an executive officer or employee of a company registered in Hungary or in any of the states determined by the minister responsible for public safety that has an affiliated relation within the meaning of point 23 of section 4 of Act LXXXI of 1996 on corporate tax and dividend tax with a company registered in at least one of the states determined by the minister responsible for public safety
  - **Provisions on competitors, sports technicians, and persons participating in sports events:**
    - **After having participated in an international sports event organised abroad**
      - a) a person who is a competitor or sports technician, as defined by the Act on sports, of a Hungarian sports organisation, or
      - b) a person participating, on the basis of a personal invitation or delegation by a Hungarian sports organisation, in an international sports event organised abroadis subject to a health screening, after which the person shall be placed in an official home quarantine in their domicile, place of residence, or the area of the real estate used for sporting activities by the sports organisation for 14 days
    - **The non-Hungarian citizen**
      - a) who is a participant, other than a member of the audience, in an international sports event organised within the territory of Hungary,
      - b) who has a personal letter of invitation issued by the official organiser of a sports competition held in Hungary,
      - c) who arrives at the invitation of a Hungarian sports organisation or national sports associationas a competitor holding a competition licence, as a sports technician, or as a person assisting in the conduct of the sports competition, with a personal letter of invitation issued by the official organiser of a sports event may enter the territory of Hungary provided that they certify that the virus could not be detected in them by furnishing a document in Hungarian or English that contains the results of SARS-CoV-2 PCR tests, carried out on two occasions within 5 days prior to entry, with at least 48 hours passing between the examinations
    - **The non-Hungarian citizen**
      - a) who is a participant, other than a member of the audience, in an international sports event organised within the territory of Hungary,
      - b) who has a personal letter of invitation issued by the official organiser of a sports competition held in Hungary,
      - c) who arrives at the invitation of a Hungarian sports organisation or national sports associationas a competitor holding a competition licence, as a sports technician, or as a person assisting in the conduct of the sports competition, with a personal letter of invitation issued by the official organiser of a sports event may also enter the territory of Hungary provided that they certify that that at the time of examination, the SARS-CoV-2 coronavirus could not be detected in them by furnishing a document in Hungarian or English that contains the results of a molecular biological examination (SARS-CoV-2 PCR test) complying with the professional rules of healthcare, carried out on a single occasion within 3 days prior to the sports event or competition, taking into account also the relevant protocol of the Union of European Football Associations.
- **In the case of airport transit, a person who is not allowed to enter the territory of Hungary may only stay in the airport transit area**
- **Rules pertaining to persons passing through the territory of Hungary:**
  - persons arriving from abroad may enter the territory of Hungary for the purpose of transit passage, provided that:
    - their health screening does not establish suspicion of the COVID-19 infection
    - they meet the entry conditions set out in the Schengen Borders Code
    - they certify in a credible way the objective of travel and the destination country
    - their entry to the destination country and any state neighbouring Hungary is ensured
  - a person who was granted entry in such cases shall be allowed to use only the route determined; may stop only for reasons inevitably necessary, and at rest areas determined; and shall leave the territory of Hungary no later than within 24 hours

In accordance with the Government Decree, at the request of the person placed in quarantine, the epidemiological authority competent to issue a decision ordering quarantine may allow the person placed in quarantine to take part in molecular biological examinations (SARS-CoV-2 PCR tests) complying with the professional rules of healthcare on two occasions within 5 days, with at least 48 hours passing between the examinations, in order to receive the exemption under paragraph 2.

**In case the molecular biological examinations (SARSCoV-2 PCR tests) carried out in Hungary on two occasions verify that at the time of the examination, the SARS-CoV-2 coronavirus could not be detected in the person placed in quarantine, the epidemiological authority competent to issue a decision ordering quarantine shall grant exemption from the provision ordering quarantine.**

**The Hungarian Government Decree 419/2020 (1 September) establishes separate rules for entry from the territories of the Czech Republic, the Republic of Poland, and the Slovak Republic.**

**The “Information on the Provision of Epidemiological Surveillance as a Temporary Measure” form shall be signed by the person concerned, after completion, before the competent police authority at the border crossing point after the verification of the data.**
