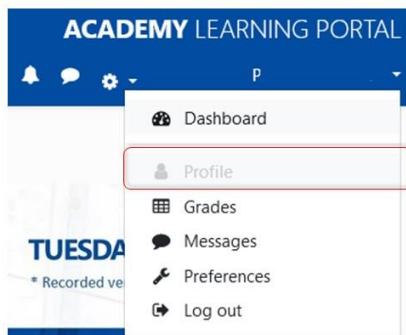

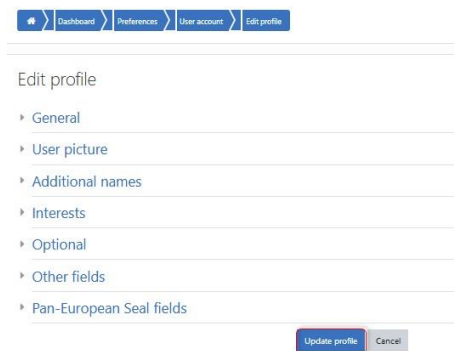


How can I make my account more personal? Fit your profile to your liking and choose the information you want to appear
