

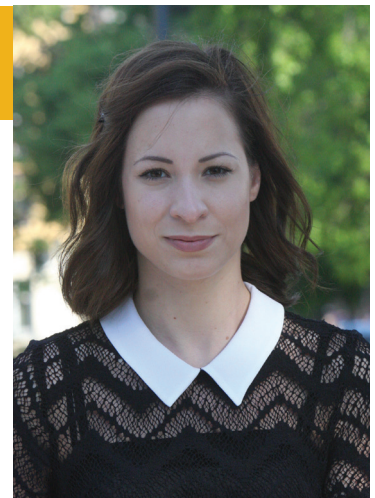


## Olívia Németh
